**To register, follow these simple steps:**

- 1. Access the website:** [cnaparagon.inquisiqlms.com](http://cnaparagon.inquisiqlms.com)
- 2. Create an account:** All users should begin by clicking the **Sign In** button in the top-right corner. New users should select the "register here" option in the pop-up field. If the Sign In field does not appear, check your browser's pop-up blocker and make sure it's set to "allow."
- 3. Enroll and pay:** After registering, select the Course Catalog link from the top toolbar, select the course and click ENROLL. If you have a PayPal account, simply log in with your credentials. If you do not, click Pay with Debit or Credit Card, provide your payment information and click Pay Now.
- 4. Access the content:** After payment is made, select the My Dashboard link from the top toolbar and click the green LAUNCH button to launch the program. Please note that the system tracks your login time and will require you to randomly interact with the program through its completion in order to comply with state CLE requirements.
